

DECEMBER 2023 Field Operations

Hyperion Water Reclamation Plant:

The Hyperion facility continues to have multiple offline battery collector tanks and final clarifiers during this period. All offline subdivisions are monitored and drained or treated by Hyperion staff.

During this period Primary Battery B, C and D systems are in offline status. Battery C1 East, Center and West long collectors tank metal covers are open, with exposed water and debris. Final Clarifiers 1A, 5C tank is offline with water and algae at the base of the tank.9A offline and dry, 2B is also offline with water at the base of the tank. Chlorination and Service Water Facility-Filter # 8 continues to be offline with stagnant water at the bottom of motor shaft drive. Sump Pump Outfall One Mile Surge overflow sump pump open hole, standing water at the bottom. One Mile Diversion Outfall Primary Sample Point (Open Hole) standing water at the bottom. Water is being pumped out at this time. At the Oxygen Reactors Tank, deck drain screens need to be replaced with new mesh. Oxygen Reactor Tanks 1A through 9C with standing water on deck.

District staff attend bi-weekly meetings with Hyperion staff to exchange information and review inspection reports. Mosquito trap counts were low during this period.
